Through the utilization of this site, the Contributing Employer represents that it has signed or otherwise agreed to be bound by a collective bargaining agreement with the International Union of Painters and Allied Trades or its affiliated District Councils or Local Unions or other participation agreement requiring contributions to the Pension Fund for hours paid or worked by covered employees.

The Contributing Employer agrees to be bound by the terms of the International Painters and Allied Trades Industry Pension Fund Agreement and Declaration of Trust and all rules, regulations, and policies adopted by the Board of Trustees. The Contributing Employer further agrees to be bound by the Pension Fund’s Policy and Procedure for the Collection of Delinquent Contributions and Payroll Audits of the International Painters and Allied Trades Industry Pension Fund, which has been adopted by the Pension Fund’s Trustees and is incorporated herein as if reproduced in its entirety.

The Pension Fund may rely on the Contributing Employer’s report of work, employees covered by the report, Social Security numbers, and other relevant factors in administering benefits and calculating amounts due the Pension Fund. The Report and Remittance through this site shall be treated as a statement to an employee benefit plan subject to criminal penalties for falsification under federal law and may be the subject of civil liability, including an action for damages. The use of the Contributing Employer’s log in and password are the legal equivalent of the signature of an officer or other agent of the Contributing Employer authorized to bind the Contributing Employer on such matters.
